

2. Candidate needs to upload the proof of payment of application fee in the above-mentioned link.
3. Publications as per SCOPUS list should be uploaded in the link.

IMPORTANT NOTES FOR CANDIDATES:

1. Date of interview will be notified at a later date on the institute website (<https://www.iiitagartala.ac.in/>). All are advised to visit Institute website regularly for updates.
2. IIIT Agartala is an equal opportunity Institute; female candidates are encouraged to apply.
3. Institute reserves the right to place a reasonable limit on the total number of candidates to be called for interview. Mere fulfilling/meeting minimum eligibility criteria do not qualify a candidate to be called for presentation.
