General Terms and Conditions:

1. The recruitment is against Non-sanctioned post.
2. The appointment against the above posts are purely on contractual basis on a consolidated pay for a fixed duration, initially for one year, which may be renewed subject to satisfactory performance. No other allowance shall be admissible.
3. No TA/DA shall be paid for attending the interview.
4. The Institute reserves its right to modify/defer or cancel the advertisement at any stage of processing without assigning any reason.
5. Incomplete applications in the prescribed form are liable to be rejected.
6. Candidates who get selected for test/interview, will have to produce original documents in support of all the particulars mentioned in their application form regarding their educational qualification, experience, and other claims.
7. Original documents along with one set of self-attested copies will have to be produced at the time of test/interview for verification.
